Certificate 3 Guarantee

Under the Certificate 3 Guarantee Program, the Queensland Government will subsidise the training costs for a range of certificate level III qualifications. Lower-level vocational qualifications (E.g. Certificate I and II) are also subsidised in certain circumstances, based on an individual's learning, skilling or support needs. The amount of subsidy provided will depend on the demand for skilled workers in the area of study.

Certificate I and/or II level qualifications (excluding VETiS) can be completed under the following circumstances:

- Individual: where the student is assessed as requiring this pathway, for example lower-level qualifications are supported for disadvantaged learners
- Qualification: where the qualification is mandated as a prerequisite for the certificate III level qualification under training package rules
- Industry: where industry or local employers have supported the qualification as the preferred employment outcome, including basic trade skills to support entry into a traditional apprenticeship pathway.

The student must supply relevant evidence of the circumstances that support the enrolment in a lower-level qualification, either at the individual, industry or pre-apprenticeship level.

Vocational Education and Training in Schools (VETiS)

All Queensland secondary school students in Years 10, 11 and 12 can access VET within any recognised qualification across a range of industries in a school environment; however VET investment funding can only be used for those qualifications identified as employment stream qualifications. Students who complete a certificate III (or higher) qualification at school can access further government subsidised training after school e.g. Year 12 fee-free training and the Certificate 3 Guarantee.

Higher Level Skills

The program provides a government subsidy to support eligible individuals to access one subsidised training place in selected certificate IV level and above qualifications, or priority skill sets. The aim is to assist individuals to gain the higher level skills required to secure employment or career advancement in priority industries or to transition to university. Employers may also be able to access training to address workforce development needs.

Eligibility Criteria

Certificate 3 Guarantee Eligibility

In order to undertake training through the Certificate 3 Guarantee, prospective students must meet the following eligibility criteria:

- with the exception of VET in Schools students, be aged 15 years or above, and no longer at school
- permanently reside in Queensland
- be an Australian citizen, Australian permanent resident, including a humanitarian entrant, a temporary resident with the necessary visa and work permits on the pathway to permanent residency, or a New Zealand citizen; and finally
- not hold, and not be enrolled in, a certificate III or higher level qualification, not including qualifications completed at school and foundation skills training.

If you have completed a Certificate III qualification (out of school) or once you complete a Certificate III qualification under the Certificate3 Guarantee Program you will no longer be eligible for a subsidised training place under the Certificate3 Guarantee Program.

VET in Schools (VETiS) Eligibility

- All Queensland secondary school students in Years 10, 11 and 12 can access VET investment for qualifications identified as employment stream qualifications.
- Has not already completed and received funding for a VETiS Employment Stream Qualification.
- Students who complete a certificate III (or higher) qualification at school can access further government subsidised training after school e.g. Year 12 fee-free training and the Certificate 3 Guarantee. .

Higher Level Skills Eligibility

In order to undertake training through the Higher Level Skills Program, prospective students must meet the following eligibility criteria:

- be aged 15 years or over, and no longer at school
- permanently reside in Queensland
- be an Australian citizen, Australian permanent resident (includes humanitarian entrant), temporary resident with the necessary visa and work permits on the pathway to permanent residency, or a New Zealand citizen
- not hold, and not be enrolled in, a certificate IV or higher-level qualification, not including qualifications completed at school and foundation skills training.

Queensland Year 12 graduates Eligibility

To be eligible for fee-free training, the student must meet the above Certificate 3 Guarantee eligibility criteria and:

- have evidence of completing Year 12 in Queensland, for example hold a Queensland Studies Authority issued Senior Statement or equivalent certification
- enrol in a high-priority qualification under the program with a PQS
- commence training within 12 months of graduating Year 12 (i.e. by the end of the calendar year after completing Year 12)

Concessional Eligibility

The government pays a higher subsidy to encourage and support participation by concessional students undertaking qualifications. Concessional student status applies when the student:

- holds a Health Care or Pensioner concession card, or is the partner or dependant of a person that holds such cards and is named on the card
- provides an official form under Commonwealth law confirming that the student, his or her partner, or the person of whom the student is a dependant is entitled to concessions under a health care or pensioner concession card
- is an Aboriginal and or Torres Strait Islander person
- Is a school student and is enrolled in a VETiS program – including youth in detention
- Is a person with a disability
- Or is an adult prisoner.

Eligibility Assessment

The Eagle Academy will assess each student's eligibility prior to enrolment and retain all evidence to verify eligibility, including whether the student meets:

- The criteria outlined in the program policy, including whether the student has previously attained a certificate III or higher - level qualification. This is done through the compulsory use of the department's AISS tool where the Academy can confirm whether prospective students have previously attained a certificate III or higher - level qualification.
- The program's criteria for concessional status
- Any specific restrictions for enrolment in a qualification outlined in the Queensland Training Subsidies List

Co-contribution Fee Arrangement

Co-contribution fees are the fees, concessional and non-concessional, that are to be charged to the student, or school (VETiS), if he/she enrolls in the qualification.

Please note that the Certificate 3 Guarantee Program Qualifications are excluded from all specials and discounts offered by The Eagle Academy.

Exceptions to Co-contribution Fee Arrangement

- Competencies assigned as "credit transfer" or "superseded" (code '60' or '61' AVETMISS Outcome identifiers).
- Queensland Year 12 graduates who enrol and commence training within 12 months of completing Year 12 (that is, by the end of the calendar year following completion of Year 12).
- VETiS students - this training is provided fee-free to students and additional costs are met by the school.
- Foundation skills — this training can be provided fee-free to students if determined by the PQS.
- Lower-level qualifications for concessional students – this training can be provided fee-free to students if determined by the PQS.
- If the student and PQS are eligible, a VET FEE-HELP loan may be available to the student to cover all or part of their contribution toward the cost of a diploma or advanced diploma level qualification subsidised under the Higher Level Skills program.
- Student cohorts exempt from paying fees as specified in the relevant program policy or guidelines.
- Community Learning funding - this training is provided fee-free to students and any additional costs will be paid by Community Learning funds. The PQS must report to the department the fees paid under the funding initiative.
- Costs associated with Australian Federal Police checks undertaken prior to vocational placement must be advertised with co-contribution fees and included in initial notifications to prospective students, as the search fee is considered to be a training cost. However, if the student is a fee-free Year 12 graduate this cost cannot be charged to the student.

There are expectations and rules regarding accessing a government subsidised training place under the relevant program, including that you may no longer be eligible for a government subsidised training place under a program once you complete the qualification level targeted through the program.
